A Filing ID refers to the identification number assigned to the business entity by the Secretary of State's Office. If you do not know your Filing ID, please search by the name of the business entity.

 $\Lambda$  The statement that a company is in "good standing" simply notifies the public that all paperwork or fees required to form or maintain registration has been filed with the Secretary of State and is current. "Good Standing" in no way implies endorsement of the business nor does it reflect on the quality of the products or services provided by the business.

We have a long history of serving the public. Beginning in April 1869 with the appointment of the first Secretary of the Territory of Wyoming, Edward M. Lee, by United States President Ulysses S. Grant, this office has always served the public from the State Capitol Building.
